Dear Residents and Family Members

Thank you for your support and patience as we continue our pharmacy partnership to distribute COVID-19 vaccines to our community. We are looking forward to the day when our residents and team members have received both vaccination shots and enough time has passed for the recipients to receive maximum protection from the vaccine. We remain optimistic that we are collectively helping "create a wall" against Coronavirus and taking these important steps to a return to normalcy. Safeguarding our residents and team members has been our most important responsibility and will continue to be our primary focus.

We understand that everyone is eager to resume activities that we all enjoyed before the onset of the pandemic. We are too. We are currently working with public health officials and medical experts to best understand the guidance and to implement a cautious and meaningful rollout. What we do know is that the CDC instructs that the vaccine reaches maximum protection approximately 2-4 weeks after the second vaccination shot. As such, at a minimum we will continue to exercise our current precautions (physical distancing, restrictions on dining and group activities, masks, etc.) for at least two weeks following our currently scheduled final clinic date.

Dr. Fauci yesterday declared that our collective efforts against COVID-19 "is about to get better very quickly." We can see this already in the latest data: The US peaked at 300,594 new COVID-19 cases in one day on January 8 right after the holidays. We are now down to 139,830 per day.
